Instructions For Filling Water Sample Containers:

1. Remove screen and aerator from faucet.
2. Run water for 3 to 6 minutes.
3. Open the container
 Do not use if the seal is broken.
 Do not rinse out the container.
4. Fill Bacteria container to 100 ml mark and Nitrate container to top.
5. Complete **ALL** information on forms that applies to your well or water system.

All water samples should be kept cold in a cooler or baggy with ice, but do not freeze. Water samples should be taken right before delivering to the lab or Health District office. (Samples should not exceed 24 hour holding period.)

Please do not use your own bottles or jars to take water samples, they have not been sterilized properly and could cause false results. This means you would have to retest and pay the cost again.

For Water Availability applications:

For a private well the health department needs a copy of your well log, bacteria, and nitrate samples with satisfactory results. The following are names and telephone numbers where you may be able to get a copy of your well log:

- * The well driller that installed the well.
- * The Health District office in Ephrata has a very limited number of well logs on file and may have a copy.

If you are going to be connected to a community water system you will need to contact the purveyor (manager) of the water system and obtain all of the information required on the water availability form.
