**Limitations in Moses Lake Health District Office
Hours Will Continue Through February 2010**

The Grant County Health District *Moses Lake office at 1038 West Ivy* will remain closed on Mondays, Wednesdays and Fridays and open on Tuesdays and Thursdays from 8:00am-5:00pm, (closed 12:00-1:00pm) through February 2010. The Ephrata office, located at the Courthouse, will remain open five days a week from 8:00am-5:00pm, (closed 12:00-1:00pm.)

Health District staff will be continuing the school based 2009 H1N1 vaccination clinics, as well as overseeing the community-wide distribution of 2009 H1N1 vaccine to health care facilities. These activities will require effort from not only public health nurses, but other agency staff as well. “With assistance from our community partners the school based vaccination clinics have been very successful. So far, we have administered over 5,600 doses in Grant County public and private schools.” states Peggy Grigg, Administrator. Now over the coming weeks the Health District will be going back into the schools and administering 2nd doses in children 9 years and younger.

Birth Certificates

Moses Lake Office: Must be purchased by 12:00 p.m. on Tuesdays or Thursdays for pick up the same day.

Ephrata Office: Birth Certificates can be ordered at the Ephrata office Monday-Friday and will be mailed or they can be picked up at the Moses Lake office on Tuesday or Thursday.

Immunization Clinic

Moses Lake Office: Adult immunization clinic will continue on TUESDAYS from 9:00-11:00 a.m.

Ephrata Office: TB, adult and children immunization clinic will remain on the first Monday of the month from 1:00-4:00 p.m.

TB Clinic

Moses Lake Office: Tuesdays 9:00-11:00 a.m. and 1:00-4:00 p.m.

Quincy TB Clinic
